## Farmer's Herd Declaration for the BVD Eradication Scheme Notes

### **Background and definitions**

The aim of the BVD eradication scheme is to identify and remove all PI animals from holdings in Scotland in order to eradicate the BVD virus.

For the purposes of the BVD Eradication Scheme, a holding is classified as 'breeding' or 'non breeding'. If a holding contains both 'breeding' and 'non breeding' herds, it must be classified as 'breeding'.

The definition of a breeding herd is:

"breeding herd" means a group of two or more bovine animals in which breeding, whether by natural, assisted or artificial means, is intended by its keeper to take place and no steps are taken to prevent or minimise the chances of such breeding.

A 'breeding' holding can have a BVD Herd Status of 'negative' or 'not negative'.

'Negative' – there is no BVD virus present on the holding.

'Not negative' – this holding has possibly been exposed to BVD virus and/or requires further testing.

A 'non breeding' holding has no BVD herd status and is referred to as 'non status'.

### **Implications of making the declaration**

On your holding, you must take steps to prevent the breeding of animals. Where any births do occur, each calf must be tested for the BVD virus within 40 days of birth. Your holding status will remain as 'non status' and you will not be given a BVD Herd Status based on the results.

Your holding will have no BVD herd status. For private sales, you must make this fact known to purchasers. You will remain as a 'non-breeding' herd.

If you decide, to breed animals, you must contact ScotEID on 01466 794323, for guidance in the reclassification of your herd.
